

Oklahoma's 59th State Legislature convened from February 6, 2023 to May 30, 2024; adjourning one day early. The Regular First Session of the legislature met from February 6, 2023 to May 26, 2023. The Regular Second Session met from February 5, 2024 to May 30, 2024.

Legislation and Methodology

A total of 328 bills and resolutions that pertained to veteran-related, veteran-centered, or had the word "veteran" within the measure's text were introduced from both legislative chambers during the 59th State Legislature. From July 11 to 17, 2024, the Convention of States Action Oklahoma Veteran Coalition Legislative Liaison Team used the highly accurate and reliable LegiScan website

(https://legiscan.com/gaits/search?sort=desc&order=Bill&state=OK&keyword=veteran) to research and compile into seven listed pages all introduced veteran legislation. A keyword search on the word "veteran" was performed. These pages are provided here:
